Purpose of Presentation

- To provide background information on how Prescott's Family Medicine clinic operates
- To explain how Prescott Family Health Team (PFHT) and Prescott Family Medical Associates (PFMA) work together to provide high-quality care for our community
- To address the challenges we are facing real and serious
- To explain how the towns and PFHT/PFMA can work together to make a difference



Introduction

- The Family Medicine clinic in Prescott started with a single-physician practice in 1968
- In 2007, Prescott Family Health Team (PFHT) was founded
- PFHT is a non-profit organization



rescott Background: Family Health Teams (FHTs)

- Family Health Teams (FHTs) are non-profit primary healthcare organizations funded by the Ministry of Health (MOH)
- FHTs were created in 2005 to expand access to comprehensive primary care services across Ontario.
 - >~187 FHTs, serving 3.4 million Ontarians
- FHTs focus on health promotion, disease prevention, and chronic disease management through a team of interdisciplinary allied healthcare workers
- All FHTs must be affiliated with one or more groups of Family Physicians (FHO)

Physician Group(s)

- PFHT is affiliated with Prescott FHO (Family Health Organization)
 - Dr. Nikhil Bhatt
 - Dr. Matthew Cooke
 - Dr. Ioannis Felemegos
- Together they form a cost-sharing partnership called Prescott Family Medical Associates (PFMA)
- Care for approx. 5200 patients (large patient rosters!)
- Their patients also have free access to PFHT services

 - ✓ Social worker

- Majority of our staff are shared employees of PFHT and PFMA

rescott Services offered Together

- Primary health care services
- Preventative Programs
 - > COPD/Lung Health Management
 - > Hypertension Management
 - > Weight Management
 - Diabetes Management
 - Smoking Cessation
 - > Immunizations
- Social Services
 - Income Support
 - Mental Health and Addictions counselling
- Access to Specialists (Gynecology, Internal Medicine and Psychiatry)
- <u>PFHT is one of the smallest FHTs in Ontario</u> and is very well supported for its size, keeping these services local





rescott Needs Assessment



Current Population of Towns:

**Ontario's aging population is already straining health care resources and is increasing health care system utilization

***Lack of family physicians and upcoming retirements will exacerbate accessibility issues

The primary care sector is overloaded!





rescott Family Physician Related Statistics

- 65% of Family Physicians in Ontario are considering leaving the profession or reducing their hours in the next five years due to burnout (OCFP, 2023)
- Almost 40% of Family Physicians are retiring in the next five years (CBC News, 2024)
- Decline in the number of medicine students identifying family medicine as their first choice (CBC News, 2023)
- There were 268 unfilled residency positions in family medicine in 2023 and 252 in 2024 (CFPC 2023/2024)
- The number of patients without a primary care provider is increasing daily
- PFMA wait list has over 500 patients!



Critical Issues at Hand

- Lack of primary care services for many people in our community
- Growing burden of documentation and paperwork for physicians
- Limited physician supply
- Difficulties in physician recruitment
- **Increasing operating costs for medical practices
- Lack of team-based care in the communities
- Widening wage gap for staff in primary care compared to other health sectors
- Physicians are exhausted and burned out, and so are our other staff!

We need investments in primary care!



- **Overhead costs include:
 - ✓ Employees' payroll, including for shared employees and other related expenses
 - ✓Other operating expenses like rent, property taxes, utilities, office equipment, medical supplies, electronic medical records, and clinic maintenance costs
 - ✓ Employees' medical benefit costs and retention and recruitment costs

It is essential to note that our doctors have chosen to pay out of pocket for a PA to improve access for their patients, considering the growing needs of the community

Inflation has caused overhead expenses to rise at a greater rate than physician compensation (CBC, March 2024)

For our group, the overhead expenses exceed 30% of the total income



Serious Consequences



- Physicians may leave Prescott FHO
- Family Health Team may get dissolved
- Employees may lose their jobs
- Difficulty in physician recruitment
- Patients may lose access to care




Population Health Risk
