# Why do I want an OPG Waterfront Licence?

The Licence permits passive recreational use of OPG waterfront property, which may include the installation and maintenance of an approved dock.

#### What are the terms?

- 5 year agreement
- You must be the owner of a private residence adjoining or across the road from the OPG waterfront
- Include your licensed area as a part of your residence, under your home insurance policy
- Passive recreational use only no alterations or permanent structures
- Release OPG from any damage, loss or injury that results from your use of the OPG property

### Why is there no Licence Fee?

In return for your use of OPG's land, Licensees are expected to maintain the property in a condition similar to that of the neighborhood, including:

- Grass cutting
- Pruning of shrubs
- · Clean up of fallen branches
- Removal of dead or fallen trees

## Reminder:

Your OPG Waterfront Licence does NOT allow:

- Fill, dredging or grading
- Changes to the shoreline (unless approved)
- Parking
- Storage of any materials, including vehicles, boats, campers, firewood, furniture, aircraft, etc.
- Installation of electrical wires, cables or transmission equipment, above or below ground
- Overnight camping
- Open pit fires (except per municipal by-law)
- Sub-licensing this licence is personal to you

"NOTE: Your Waterfront Licence is a non-exclusive agreement and the Sketch of the Licensed Lands is an approximate representation. In the event of any boundary disputes between adjaining Licensees, OPG will not mediate or be involved.
